IN CONSIDERATION of being permitted to participate in River Friends activities and events, including but not limited to canoeing, kayaking, any other paddle sports and water sports, and any related activities including, but not limited to, river cleanups, I, for myself, and for my personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I understand the nature of the "Activities" and that I am qualified, in good health, in proper physical condition to participate in such activities, and willingly agree to comply with the stated and customary terms and conditions of participation. I agree that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in any Activity. If I decide to leave early and not complete a trip or event as planned, I also assume all risks inherent in my decision to leave. I give permission for any photos of me, taken during the event, to be used online and in print by River Friends.

I acknowledge that Friends assumes no responsibility for my use (during or in relation to an activity) equipment, supplies and other possessions (including, but not limited to: watercraft, accessory equipment, personal gear, or vehicles) brought to an activity by me or by a third party. Such third parties include, but are not limited to, other participants in an activity
